## Press Release: C-Path's CDRC Meeting Highlights the Importance of Drug Repurposing


TUCSON, Ariz., May 4, 2023 – The CURE Drug Repurposing Collaboratory (CDRC) held a three-day annual meeting, April 18- 20, in Crystal City, VA. The event, hosted for both live and virtual attendees, was tailored for drug repurposing stakeholders and featured expert presentations, panel discussions, keynote speakers and was attended by more than 100 patients, researchers, clinicians, biopharmaceutical company representatives, regulatory reviewers, and scientists.

### Publication of results of the WHO Survey



Between January and March 2022, WHO conducted a global online survey to collect information on the medicines used to treat subcutaneous or implantation mycoses worldwide. The survey was designed as part of a WHO collaborative project with the United States Food and Drug Administration (USFDA) to identify priority disease areas for pilot testing in CURE ID, a web-based application to help clinicians share their experiences in managing difficult-to-treat infectious diseases and thereby inform clinical research needs to support drug repurposing. The 2022 global WHO online survey investigated the use, and value in the use, of the CURE ID platform to inform drug repurposing for implantation mycoses in their non-respondent forms. The outcome of the survey will help WHO to better understand 2 the epidemiological situation as well as current practice and limitations in the management of these diseases in different regions.
